Rain, sleet or snow,  
the mail must go!



Last year was a busy winter for everyone; with snow blowers and snow plows becoming a regular sight. Did you know that frequent snow plowing can lead to loose and possibly damaged mailboxes. For this reason, homeowners are reminded to be sure their mailboxes can withstand the impact of snow thrown from a snow plow.

During winter storms, PennDOT and municipalities focus on removing snow from roadways which

may result in mailboxes taking a beating. Homeowners should frequently check mailbox supports and remember to remove snow from in front of the mailbox, allowing easier access for mail deliveries. Homeowners should never shovel snow onto the road.

PennDOT has plans available for a cantilevered mailbox support that will swing a mailbox out of harm's way. ### WALKING SAFETY & PENNSYLVANIA LAWS

Before making a walk part of your commute, make sure you know how to be safe. Here are some basic safety guidelines and pedestrian laws. Did you know that most accidents involving pedestrians occur while crossing the street? Here are some safety tips:

~Just because the light is green doesn't mean it's safe: Before you step off the curb, always check to the left, right and left again to make sure it is safe to cross the street.

~Yield to motorists if you're not within a crosswalk at an intersection or marked crosswalk.

~You have the right of way at crosswalks and intersections where there are no traffic signals. You need to clearly be in the crosswalk and to signal your intent to cross to the motorists. Make eye contact with the motorists. Do not cross the cross-

walk if a motorist cannot stop in time. Do not suddenly leave a curb or other place of safety and move into the path of a vehicle that is so close to constitute an immediate hazard.

~Be safe, use the sidewalks. It is unlawful to walk along the roadway when a sidewalk is available.

~Where a sidewalk is not available, you must stay on the shoulder as far from the edge of the road as possible.

~Pedestrian should obey traffic signals. The driver of a vehicle emerging from or entering an alley, building, private road or driveway shall yield the right-of-way to any pedestrian approaching on any sidewalk extending across the alley, building entrance, road or driveway.

**CARDBOARD (corrugated only):** This large red cardboard dumpster is located behind the township building, 100 Hill Rd. It is a collection site for corrugated cardboard. To describe corrugated cardboard, it has a fluted corrugated sheet and one or two flat outer boards. People often confuse corrugated with paperboard. Paperboard is not corrugated cardboard; paperboard is often flat, stiff and coated to give a glossy appearance (such as cereal boxes, shoe boxes, tissue boxes). Please do not place paperboard, styrofoam, plastic or wood in this dumpster. When transporting the corrugated cardboard, please break it down so it fits into the dumpster slots. Spread the word to schools, scouts, clubs, businesses, etc. Anyone serving as a mini collection site can bring larger amounts to the site.

**CELL PHONES:** The cell phone collection box is located in the Township lobby area, 100 Hill Rd. The Township properly disposes of your unwanted cell phones, cell phone batteries, and their chargers. Please delete all pertinent information from your cell phone before dropping off.

**CHRISTMAS TREES:** During the season, the Township will properly dispose of your Christmas tree. Please take off all decorations, any string, and any bag that you used for transporting. The drop off location is behind the Township building, 100 Hill Rd. Follow the posted signs.

**FLUORESCENT BULBS (CFL):** The small "spiral" bulbs are collected at the Township. The CFL collection

bucket is located in the lobby area, 100 Hill Rd. Sorry, no long tube lights are taken at the Township; call your hauler or transport them to Lancaster County Solid Waste Authority 397-9968.

**PAPER:** This large red paper dumpster is located behind the Township building, 100 Hill Rd. It is a collection site for any type of paper product such as newspaper, phone books, catalogs, computer paper, junk mail, manila folders, stationary, carbonless paper, office paper, etc. Please take out any paperclips before placing in the dumpster (staples can be left in the magazines). If you use plastic bags for transporting, the bag can be placed in the dumpster too; however, no string please. The dumpster drop slots can accommodate approximately six-inches at a time. Spread the word to schools, scouts, clubs, businesses, etc. Anyone serving as a mini collection site can bring larger amounts to the site.

**WOODY WASTE SITE:** This site is located behind the Township building, 100 Hill Rd., and is for East Cocalico Township residents only (no commercial dumping). It is for limbs and stumps less than 12" in diameter. The site is not for leaves, grass, furniture, bricks, treated wood, sod, green plants, flowers, mulch, pine needles, or any other trash of this nature. Composting at home is another great alternative! M-F 8-4:30, no Sundays or Holidays.

**Last day to register to be eligible to vote at the ensuing November election**

October 6

As soon as possible after ballots are printed and in no event later than this day, county Board of Elections must begin to deliver or mail all absentee ballots for the Election

October 21

No earlier than this date nor later than November 1, county Board of Elections to issue Election Proclamation

October 25

Last day before the Election Absentee Ballot Application shall be received in the office of the county Board of Elections at any time prior to 5 p.m. from certain persons

October 28

All absentee ballots must be received by the county Board of Elections no later than 5 p.m. on this date to be valid

October 31

**General Election** - Polls to remain open continuously between the hours of 7 a.m. and 8 p.m.

November 4

First day to register after Election.

November 5

County Return Board meets at 9 a.m. to compute and canvass the returns of the Election.

November 7

By this date, county Board of Elections to certify the results of the Election to the Secretary of the Commonwealth and to such other authorities as may be provided by law

## WHAT TO DO WITH THOSE

## LEAVES?

**MULCHING** is simple, environmentally friendly, and a cost effective way to fertilize the soil. A mulching blade chops the leaves into small pieces. Start by setting your mower height and remove the bag.

**COMPOSTING** is another simple, environmentally friendly, and cost effective way to fertilize the soil and make natural fertilizer. To start, make a pile of leaves and mix in some grass clippings (5 to 1 ratio). Stir every two weeks or so. In the Spring you will have nutrient-rich mulch for gardens and flower beds.

**BAGGING:** A not-so-simple process that costs money. Leaves are placed into bags and placed out for your trash hauler. Ask your trash hauler what the pick-up days are, and costs. Kraft bags are available at the East Cocalico Township Building for the residents.

For a fee, Martin's Mulch Products, 55 Woodcrest Dr., Ephrata takes leaves. Call for more information 733-1602.

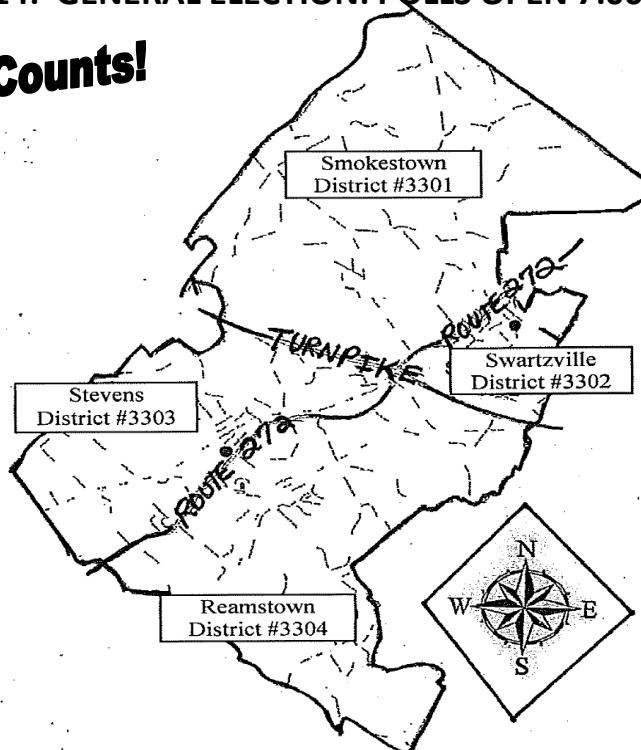

## Water Meter Replacement Project Nears Completion

The Authority's water meter replacement project begun in September of 2013 is now nearing completion. When this project concludes over the course of the next few weeks the Authority will have replaced approximately 2,300 aging residential water meters with state of the art radio read meters. In addition to being extremely accurate these meters will allow the Authority to better maintain the water system and more efficiently take readings and prepare the billing each quarter.

Over the last few months letters were sent to each of the Authority's residential accounts requesting the property owner to contact our installation contractor, Lenegan Plumbing & Heating to schedule their appointment for the meter replacement. A special thanks to the great majority of customers who responded to that request! **If you have not had your water meter replaced or scheduled your appointment, now is the time to do so. There is no cost to you for the meter or for the installation work.** It usually takes less than 30 minutes to install the meter. ## Emergency Notification *Are You Included?*

The Authority uses an automated rapid notification system to contact our water customers in the event of an emergency or problem with the water supply. In order to contact you we need your landline or cell phone number. The Authority has landline phone numbers for most of our customers. However, if you have recently moved into the area, changed your phone number or use a cell phone as your primary means of communication we need to hear from you. If you have not already done so, please take a moment to update your contact information. Updating your information is quick and easy.
