There are a few aspects of real estate tax payments that occasionally cause confusion among township residents. The four most common sources of confusion are: (1) the payment of Hydrant and Street Light Taxes, which are listed on the same bill with the Lancaster County and East Cocalico Township Real Estate Taxes in the spring, (2) the payment of School District Real Estate Taxes in the fall, (3) the application of the Homestead/Farmstead Exclusion, and (4) the Pennsylvania Property Tax and Rent Rebate Program. The four sources are described further below:

(1) On your spring tax bill are listed four included taxes: East Cocalico Township Real Estate Tax, Lancaster County Real Estate Tax, East Cocalico Township Hydrant Tax, and East Cocalico Township Street Light Tax. The discount (if paid by April 30th), face (if paid by June 30th) and penalty (if paid after June 30th) amounts for each of those taxes follow those headings. Not all East Cocalico Township properties are assessed a Hydrant and/or Street Light Tax. Properties, any portion of which lies within 750 feet of a hydrant, are assessed a Hydrant Tax. And properties, any portion of which lies within 250 feet of an activated Street Light, are assessed a Street Light Tax. If there are zeros in the columns after the Hydrant and/or Street Light Tax headings, your property is not included in those parameters and you are not paying any taxes for those entities. In the "Millage" column on your spring tax bill there are listed the rates for all four taxes included in the bill. The East Cocalico Township and Lancaster County Real Estate Tax rates and the East Cocalico Township Hydrant Tax rates are

listed in millages (.001 of your property assessment). The East Cocalico Township Street Light Tax rate is listed in cents assessed per foot of property road frontage.

Residents sometimes confuse those rates listed as a tax amounts due for Hydrant and/or Street Light Tax. That rate listing is simply informational regarding the method of calculating the taxes that are included on the general bill. Because there are Hydrant and Street Light Tax rates written on your bill, that does not necessarily mean that you are being taxed for either or both. If there is a zero listed next to the tax description for either or both on the upper portion of your bill, then you are not being billed for that tax.

- (2) Cocalico School District taxes are mailed in July and collected in the fall. East Cocalico Township does not collect School District Taxes. They are collected by the Cocalico School District itself and must be mailed to the address listed on the bill. All questions regarding Cocalico School District (fall) taxes must be addressed to Ausma Buffenmyer at the school district tax office, at 717-336-1406.
- (3) The Pennsylvania Homestead/Farmstead Exclusion for Tax Relief applies only to a reduction in your (fall) School District Taxes, not your (spring) County, Township, Hydrant or Street Light Taxes. East Cocalico Township has nothing to do with that Exclusion. If you have any questions regarding the Homestead/Farmstead Exclusion, you should visit the H/F Pennsylvania CDED website for answers and information: http://dced.pa.gov/local-government/property-tax-relief-homestead-exclusion/#.V PT5v8VAdU.
- (4) The Pennsylvania Property Tax/Rent Rebate Program is a state-run program that offers relief to senior and disabled residents. There are age, income and/or disability requirements that must be met in order to qualify for the program. ## **SNOW CLEARING TIPS**

Residents are asked to remove vehicles from the street when a snowstorm is occurring. It makes plowing safer and more efficient if the plow drivers do not have to maneuver around parked vehicles. To avoid snow from ending up in your driveway, wait until the road has been completely plowed to the curb before shoveling the last 5-10 feet of your driveway. This way less snow from the road will end up in your driveway. Please remove cars from the roads. When the roads are plowed curb to curb, there will be room to park your cars after the storm. ## **SNOW AND ICE**


Snow and ice must be cleared from the sidewalks within 24 hours after a snow/ice storm to a pathway width of 24 inches. Throwing, tossing, blowing, or depositing snow/ice onto any public road is prohibited. Please keep the fire hydrants cleared of snow and ice.

### FIREPLACE SAFETY

Make sure your chimney is cleaned at least once a year or more. Use only dried wood (causes less smoke and dirt) and never use flammable liquids to start a fire. Dispense of the cool ashes in a metal container with a lid away from the house; and not on the porch. Never leave a fire unattended. When burning, please keep the damper open, flammable material away, and the glass door/screen closed. Have a safe wood-burning season!

A special thankyou in advance to the residents for being patient and cooperative during the snow plowing season. If at all possible please wait to shovel the last 5 feet of your driveway until the road has been plowed to the curb. This is greatly appreciated!

# Protection Workshop 9:00 AM, Saturday, March 5, 2022 (rain/snow date March 12)

East Cocalico Township and Denver Borough will hold an in-person outdoor workshop at the East Cocalico Township Building, 100 Hill Road, Denver, PA 17517. Ryan Davis, a streambank restoration expert from the Alliance for The Bay, will present a program on protecting streambanks from erosion. Among other strategies, he will concentrate on using live-stakes as one of the simplest methods for reducing streambank erosion. The program will include a demonstration of the methods on Stony Run adjacent to the Township Building.

Participants should <u>sign up for the program by February 18th</u>, and if desired, can request up to 15 live-stakes (various species will be available) for their own use. We will also provide information on sources for additional live-stakes if needed. The live-stakes will be free if they are to be used for a streambank on your own property.

### **COLD WEATHER REMINDERS**

With cold weather on the way, here are some cold weather tips you can follow to keep your water service working as intended:

- Wrap exposed water pipes with insulating material to help prevent freezing.
- Check outside faucets to make sure they are turned off and disconnect any hoses.
- Make sure heat can reach your water pipes and water meter. Pay particular attention to water pipes enclosed in bathroom cabinets, kitchen cabinets or in crawl spaces.

## **ACCESS TO FIRE HYDRANTS**

ECTA currently maintains 358 fire hydrants throughout the Township. As we move into the winter months, we would like to encourage residents living near a fire hydrant to help us keep those hydrants accessible by removing any accumulated snow that may block or hide them. Snow should be removed a minimum of three feet completely around the hydrant in order to provide the fire company with unobstructed access. With the large number of hydrants we maintain throughout our water system, it can take some time after a snow storm before our employees can inspect and clear all of them. Any assistance you can give us in keeping our hydrants clear of snow is greatly appreciated, and your neighborhood and local fire companies will benefit from hydrants that are readily visible and easily accessible.

## **HOW CAN MY WATER USAGE BE THAT HIGH?!?!**

Some situations cause a legitimate increase in your water usage such as adding another person to your household, children returning home from college, watering plants/gardens, and filling a pool just to name a few. However, when it comes to surprisingly high water bills, a leak is usually the cause. How can you keep this surprise from happening to you? By being proactive and monitoring your own water meter and usage. ECTA reads your water meter quarterly for billing, but we encourage you to check your water meter and usage on a regular basis throughout the quarter. Open the black, flip top lid on your water meter and you will see a small, silver, flower-shaped leak indicator in the center of the face of your water meter. If that leak indicator is spinning when you are not using water, this indicates the presence of a leak. When some customers think of water leaks, they assume they will see puddles on the floor, but this is not usually the case. Some common sources of leaks are a running toilet, a malfunctioning water softener, and leaky faucets, among others. ECTA requires that all leaks be repaired immediately by the consumer. Be aware that no allowance will be given for water that has passed through the water meter. You can also track your water usage by reading your water meter as often as you choose to do so. Open the black, flip top lid on your water meter and you will see the meter dial. Simply write down the reading (including the stationary zero at the end of the dial) and subtract the readings to see how much water has been used since the last time you read the meter. Also, it is a good idea to turn off the water at your isolation valve inside the home when you are planning to be away for an extended period of time. Taking these few easy steps could help you avoid an unexpected and possibly significant increase on your next bill.

#### **ECTA PROJECT UPDATES**

ECTA has been hard at work with construction and design efforts this year aimed at improving and expanding our water and sanitary sewer facilities to better serve our community's current needs and ongoing growth. Some key efforts include the following:

- Stevens Pumping Station Upgrade/Expansion ECTA is making progress with construction activities for the upgrade and expansion of our sanitary sewer pumping station in Stevens, located along Line Road near the intersection of Wabash Road. The station has been approaching full capacity and required an upgrade to support future growth. On-site construction is to be completed by December 2021 with startup targeted for January 2022.
- Meadowbrook Area Water and Sewer Rehabilitation & Replacement ECTA is well underway with engineering and design activities for a \$5.5 million project aimed at repairing and replacing over 9,000 feet of damaged or leaking sanitary sewer main and over 10,000 feet of antiquated cast iron water line. Final design and bidding of this project should be completed by December 2021 with construction starting in Spring 2022 through December 2023.
- Well M Project ECTA is nearing the end of construction activities for our new public water supply Well M located along Line Road. The Well M project moved into the construction phase in December 2020 and is scheduled to be put into service by the end of 2021. The addition of Well M to our public water system will help ensure our customers a reliable and steady supply of water for many years to come.
