• Chair Bonura announced the Board of Supervisors met in Executive Session on October 5, 2023 to discuss a personnel matter, in specific the Public Works Director position.

MEETING MINUTES

Sue Mackley, East Cocalico Township, commented on a motion included in the minutes.

Doug Mackley, East Cocalico Township, commented on public comment included in the minutes.

Chair Bonura made a motion to approve the October 5, 2023 Meeting minutes, revised to amend a comment regarding Township marketing at page 2. The motion was seconded by Mr. Mitchell.

There was no additional public comment.

By unanimous vote the motion was approved.

ACTION ITEMS

<u>Chief of Police appointment</u> – Chair Bonura made a motion to appoint Steven C. Savage as Chief of Police for East Cocalico Township, effective October 20, 2023, and to approve an agreement as to the Terms of Employment, dated September 25, 2023. The motion was seconded by Mr. Mitchell.

There was no public comment.

By unanimous vote the motion was approved.

Chair Bonura administered the oath of office.

Chair Bonura recognized Chief Savage for his service to the community, and noted his ability to successfully lead the Police Department.

Chief Savage thanked his family, fellow Police Officers, and the Board of Supervisors for their support, and commented on that he will do to help keep our community safe in the years to come.

<u>Public Works Director ratification</u> – Tommy Ryan, Township Manager, provided an overview of the education and experience of Public Works Director candidate Abraham Stick.

Chair Bonura made a motion to ratify the hire of Abraham D. Stick as Public Works Director for East Cocalico Township, effective October 23, 2023, subject to the terms set forth in a conditional offer of employment dated October 16, 2023. The motion was seconded by Mr. Mitchell.

There was no public comment.

By unanimous vote the motion was approved.

<u>Ordinance 2023-03</u> – Matt Creme, Township Solicitor, announced and opened a Public Hearing to consider Ordinance 2023-03 at 7:08 PM.

A court reporter transcribed the proceedings.

Mr. Creme closed the Public Hearing at 7:31 PM.

Mr. Carrasco made a motion to adopt Ordinance 2023-03, to amend the Official Zoning Map of East Cocalico Township to rezone portions of certain properties at North Reading Road and Wabash Road from the Suburban Residential Zone and General Commercial Zone to the Light Industrial Zone, and from the General Commercial Zone to the Suburban Residential Zone. The motion was seconded by Mr. Mitchell.

There was no public comment.

The motion was approved 2-1, with Chair Bonura voting no.

Ordinance 2023-04 – Mr. Creme announced and opened a Public Hearing to consider Ordinance 2023-04 at 7:32 PM.

A court reporter transcribed the proceedings.

Mr. Creme closed the Public Hearing at 8:08 PM.

Chair Bonura made a motion to adopt Ordinance 2023-04, to amend the Official Zoning Map of East Cocalico Township to rezone a property at Pfautz Hill Road from the Suburban Residential Zone to the Mobile Home Park Residential Zone. The motion was seconded by Mr. Mitchell.

There was no public comment.

The motion was approved 2-1, with Mr. Carrasco voting no.

Ordinance 2023-05 – Mr. Creme announced and opened a Public Hearing to consider Ordinance 2023-05 at 8:09 PM.

A court reporter transcribed the proceedings.

Mr. Creme closed the Public Hearing at 8:16 PM.

No action was taken on the proposed ordinance.

Resolution 2023-12 – Mr. Creme announced and opened a Public Hearing to consider Resolution 2023-12 at 8:17 PM.

A court reporter transcribed the proceedings.

Mr. Creme closed the Public Hearing at 8:19 PM.

Chair Bonura made a motion to adopt Resolution 2023-12, to adopt the Comprehensive Plan for the Cocalico Region as the comprehensive plan for East Cocalico Township. The motion was seconded by Mr. Carrasco.

There was no public comment.

By unanimous vote the motion was approved.

The meeting recessed at 8:20 PM, and the meeting reconvened at 8:27 PM.

<u>Benderson Development Company, LLC (RZ 2023-04)</u> – Claudia Shank, Counsel for the Petitioner, provided an overview of a property at Colonel Howard Boulevard proposed for rezone, so to allow warehouse, retail, and convenience store with fueling station uses. Ms. Shank commented on previous zoning and proposed uses.

Mr. Mitchell commented on the development of commercial uses in the Township. James Boglioli, Petitioner, commented on marketing efforts made to date, and on development trends.

Chair Bonura commented on mixed-use developments in the region. Mr. Mitchell commented on redevelopment activity in the region.

Steve Brubaker, East Cocalico Township, commented on potential medical use.

Dan Burton, East Cocalico Township, commented on traffic and site egress.

David Hollinger, East Cocalico Township, commented on potential infrastructure improvements.

Mr. Carrasco made a motion to accept and refer out for reviews a petition to rezone certain properties at Colonel Howard Boulevard, Lausch Road, and North Reamstown Road, as submitted by the Benderson Development Company, LLC (RZ 2023-04). The motion did not receive a second.

<u>320 Hill Road</u> – Mr. Ryan provided an overview of an application made for a small stormwater project at 320 Hill Road.

Mr. Creme noted Chair Bonura had submitted notification of a conflict of interest in voting on this matter in advance of this evening's meeting. Mr. Creme noted Chair Bonura is the property owner.

Mr. Mitchell made a motion to approve a stormwater plan, improvement agreement, and maintenance easement agreement at 320 Hill Road. The motion was seconded by Mr. Carrasco.

There was no public comment.

The motion was approved 2-0, with Chair Bonura abstaining.

<u>0 Mohns Hill Road</u> – Mr. Ryan provided an overview of an application made for a small stormwater project, and waivers, at a property at Hill Road.
