### RECREATION BOARD MEETING TUESDAY, OCTOBER 12, 2021

The regularly advertised meeting of the East Cocalico Township Recreation Board was called to order on Tuesday, October 12, 2021 at 7:00pm held at the East Cocalico Township Municipal Building, 100 Hill Rd., Denver, PA 17517.

#### **ATTENDANCE**:

Rec Board: Vice Chairman Tara Erkinger, Secretary Steve Brubaker, and Philip Wiest

<u>REORGANIZATION</u> - <u>SELECTION</u> OF NEW CHAIRPERSON: Discussions were held concerning a temporarily re-organization due to the current Chairman's situation. After discussions, the following motion was made.

**MOTION:** Secretary Brubaker made a motion, seconded by Philip Wiest, to recommend Tara Erkinger fill-in and assume the responsibilities and duties of Recreation Board Chairman while the current Chairman Eddy McAlanis is awaiting his court date. There were no comments or questions. Motion carried (3/0).

MEMBERSHIP VACANCY – INTERESTS IN SERVING ON RECREATION BOARD: Brent Wilson and William Erkinger were in attendance. The Recreation Board discussed and highlighted some of the current project items and the Pool Committee. Lengthy discussions. Secretary Brubaker noted the possibility of concerns that may arise with spouses sitting on the same board (William and Tara Erkinger are husband and wife). Discussed if there is anything in the by-laws that this may be considered a conflict of interest, or that it may be construed as negative within the community. After some discussions, it was determined to wait until the next Recreation Board Meeting to discuss the possible appointment of William Erkinger, and to discuss with the Township Manager that there is no mention of spouses serving on the same Board within the by-laws. Discussions continued, and the Recreation Board agreed to put a hold on recommending William Erkinger until next month.

**MOTION:** Secretary Brubaker made a motion, seconded by Vice Chairman Erkinger, to recommend the appointment of Brent Wilson to the Recreation Board, and to place a hold on the recommendation of William Erkinger until next month. There were no comments or questions. Motion carried (3/0).

SUPERVISORS: Pool fencing and pool intercom system may need replaced, discussed gathering contractor names and pricing for estimates for the November Recreation Board Meeting. Discussions continued. Reported that the cinderblock wall issue in boys bathroom near the shower appears to need replaced. Vice Chairman Erkinger to talk with the Township Manager about possibly the Road Crew could look at or how should we handle to get that quote/fixed. Discussions were held on the walking path in Reamstown Municipal Park, if quotes should be obtained for concrete and/or blacktop since there are major falling hazards within that path. Phil Wiest will reach out to Eddie about budget for Frisbee Golf Reamstown and Denver connection. Discussions were held on the Township budget and the possibility to get items in the budget. Brent Wilson mentioned his neighbor is an eagle scout and would like to do his project with the Basket Ball Nets/Hoops at Reamstown Municipal Park, Phil Wiest to contact him to get more details and have him come to the next meeting.
