RECREATION BOARD MEETING TUESDAY, MAY 10, 2022

The regularly advertised meeting of the East Cocalico Township Recreation Board was called to order on Tuesday, May 10, 2022 at 7:00pm (with the Work Session starting at 6:15 p.m.) held at the East Cocalico Township Municipal Building, 100 Hill Rd., Denver, PA 17517.

OLD HOMESTEAD - SOCCER FIELD DISCUSSIONS: This item was moved up on the Agenda to accommodate the visitor in attendance. Phil Wiest stated that he took measurements of the park, and determined that it would be physically feasible to host soccer at Old Homestead while still having room for residents to gather and play at the same time. Phil Wiest noted that Weaver Markets volunteered the use of their parking lot (connected to the park via the paver path) so that cars will not need to enter the development (with the exception of handicapped family members). Lengthy discussions were held with the possibility of Old Homestead Park hosting soccer in the fall of 2022 and spring of 2023. Discussions continued, and noted that it would be ideal to find a permanent home for youth soccer outside of housing developments; and Hill Road was discussed as a possible location, as well as local Fire Companies being an ideal location. The CYS program would seek out other places to practice & play their games besides Old Homestead. Discussions continued. Andrea Loud will follow up at a future Recreation Board Meeting. Stephanie Santoro discussed, noting that she is upset with soccer being held at Old Homestead: (1) not enough room for the fields and their safety, (2) constantly vehicles flying in and out of the area, and (3) not adequate parking on the roads. Discussions were held stating that there were problems before. It's noted that vehicles block residential driveways. Ms. Santoro stated that she, and others at Old Homestead, are against a soccer field at that location. Other possible dedicated land locations were discussed. Lengthy discussions were held. Comments and questions were asked which were answered. The Recreation Board thanked Ms. Santoro for attending tonight.
