<u>APPROVAL OF MINUTES:</u> The draft Tuesday, August 8, 2023, Recreation Board Meeting minutes were before the Recreation Board for approval. Amendment needed to update Stoney Pointe DCNR Grant drainage replace "playground" add "property".

WABASH LANDING COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG): No new updates to report.

WARWICK TO EPHRATA REGIONAL TRAIL (WERT): No new updates to report.

BOY SCOUT EAGLE PROJECTS: Eagle Scout Aaron Wilezek's father presented project updates. Discussion was held around works completed to date. Agway 7' fencing is on schedule for completion by October 1. Four concrete park benches are planned, the mold will go back to the township for future bench requirements. Requested Recreation Board consider estimate to replace lights over this park to LED. Mr. Wilezek will forward that to the Recreation Board. Aaron raised over \$10K, will be \$1K short for seal coating and is requesting the Recreation Board / Township donate the final fundings to complete project. Lorraine pledged to donate \$500 from her welding company. Wilezek's will provide a cost / budget analysis that the Recreation Board will use to share with Tommy.

REAMSTOWN POOL/MAINTENANCE: Discussion held around end of the season and pool closing. Discussion was held with Jim Summers from Ephrata Recreation Center around staffing. Heather, President from East Cocalico Swim team was in attendance and gave an update on the swim teams season and thanked East Cocalico Township for use of the pool and support.

SOCCER FIELDS: Phil spoke with the club and followed up with St. Paul's Pastor and they are working together to coordinate this. No further updates.
