## RECREATION BOARD MEETING TUESDAY, JUNE 8, 2021

The regularly advertised meeting of the East Cocalico Township Recreation Board was called to order on Tuesday, June 8, 2021 at 7:00pm held at the East Cocalico Township Municipal Building, 100 Hill Rd., Denver, PA 17517.

#### **APPROVAL OF MINUTES:**

**MOTION:** Vice Chairman Erkinger made a motion, seconded by Chairman McAlanis, to approve the Tuesday, March 9, 2021 Recreation Board minutes. There were no comments or questions. Motion carried (4/0).

#### **DISCUSSION ITEMS:**

a) **RECREATION BOARD OPENINGS:** Chairman McAlanis noted that there are two people that have expressed an interest in the open positions of the Recreation Board. Discussed and highlighted that there are lot of items happening with the area parks and the pool, that the member commitment standards on attendance and on meeting a quorum at their meetings. The Board appreciates their interests, and asked that the Township staff contact them so they can attend the next Recreation Board meeting. Lengthy discussions continued.

**b) POOL COMMITTEE UPDATE:** Chairman McAlanis discussed an advertisement to be placed for the Pool Committee to have a meeting. Chairman McAlanis discussed the items needing done with the pool, and discussions related to partnering with the pool committee, the divisional swim team, the July 24<sup>th</sup> event (6-7 swim teams coming into the area), and the Reamstown Community Center. Lengthy discussions continued in reference to the July 24<sup>th</sup> and the events possible: coupons from restaurants, bounce house, and other events. Comments and questions were asked which were answered. Chairman McAlanis called the President of the Swim Team (Dawn Orgera) and she was on speaker phone with the Recreation Board. Ms. Orgera stated the event will start at 8:00 a.m. and possibly continue until 3:00-4:00 p.m., the following items are considered: rented Portable Restrooms, food vendors, awards to be presented, \$5 entry fee, PA system, timing board, discussed having bleachers, and any advertisement will be posted for a fee. Ms. Orgera stated that a bounce house is a good idea, and the possibility of the Fire Companies, EMT's, and Police bringing their vehicles for entertainment.

#### c) REAMSTOWN POOL DISCUSSION:

**d) BEGINNER SKATEPARK UPDATE:** Nancy noted that she talked with Aument Concrete stating they are looking at the 2<sup>nd</sup> week of July (weather permitting). Signage was discussed for the Skatepark suggested to be placed at the beginning of the pathway. Mr. Hession to bring this before the Board of Supervisors

**MOTION:** Vice Chairman Erkinger made a motion, seconded by Secretary Brubaker to recommend to the Board of Supervisors to place a sign at the start of the Reamstown Memorial Park pathway stating no skateboarding (anything with wheels) are allowed past this point. There were no comments or questions. Motion carried (4/0).

Vice Chairman Erkinger discussed the possibility of a grand opening. Arment concrete suggested sometime in August. "Vans" was discussed for a possibility to be at the grand opening. Permitting fees were discussed, suggesting that the Township waive any permitting fees. Vice Chairman Erkinger to present a list of recommended items at the next Recreation Board Meeting.

e) STONEY POINTE PARK UPDATES: Chairman McAlanis noted that basically everything is done, pending the hardware for the swings, the rocks on the rock walls, back parameter, schedule being worked on for the mulch to be delivered. Discussions and suggestions continued on the opening, and sending a recognition thank you letter with pictures to all involved, specifically the school. A draft letter to be prepared by the next Recreation Board Meeting.

**f) REAMSTOWN BASKETBALL COURT RESURFACING UPDATE:** Chairman McAlanis highlighted the excellent work that was done on the resurfacing the court. Discussions continued on what can be placed on the outside of the court.

**MOTION:** Chairman McAlanis made a motion, seconded by Vice Chairman Erkinger to recommend to the Board of Supervisors to upgrade the basketball backboards, the rims/netting, and the lighting at the Reamstown Basketball Court. There were no comments or questions. Motion carried (4/0).
