RECREATION BOARD TUESDAY, JANUARY 17, 2017

The regularly advertised meeting of the East Cocalico Township Recreation Board was called to order on Tuesday, January 17, 2017 at 7:00pm held at the East Cocalico Township Municipal Building, 100 Hill Rd., Denver, PA 17517.

MOTION: Vice Chairman High made a motion, seconded by Joe Becker, to appoint Jim Brossman as Chairman of the East Cocalico Township Recreation Board. There were no questions. Motion carried. (3/0)

MOTION: Ralph Buckles made a motion, seconded by Chairman Brossman, to appoint Curtis High as Vice Chairman of the East Cocalico Township Recreation Board. There were no questions. Motion carried. (3/0)

MOTION: Ralph Buckles made a motion, seconded by Chairman Brossman, to appoint Joe Becker as Secretary of the East Cocalico Township Recreation Board. There were no questions. Motion carried. (3/0)

PUBLIC COMMENT: Mr. Mitchell discussed the deficit of the Reamstown Pool, and suggested that by people paying an approximately \$50 for a Park Hopper (or Fast Pass, which would allow people to go to the Adamstown and Denver pools as well. Mr. Mitchell stated that he discussed this with both Adamstown and Denver Borough and they noted they would be willing to sit down and talk about it. Discussions held on the 2017 pool rates, the costs of the surrounding pools, discussions held concerning the possibility of the pool grounds to be mowed by a lifeguard during their non-busy times, discussed recommending to the Supervisors increasing the costs, and the possibility of business banners placed on the pool fence for a cost from the business. It was noted that the Recreation Board is in charge of making recommendations about the Reamstown Pool to the Board of Supervisors. Chairman Brossman recommended general discussions at a Board of Supervisors Meeting to go over the Reamstown pool numbers to help reducing the deficit. A list was generated of fundraising details and forward to the Board of Supervisors for review and consideration of placing an article in the Township Newsletter. Lengthy discussions continued.

MOTION: Secretary Brossman made a motion, seconded by Vice Chairman High, to approve the Tuesday, October 18, 2016. No questions or comments were offered. Motion carried. (4/0)
